

## **INNOVATION CREDIT UNION COMMUNITY INNOVATOR AWARD**

### **About the Award**

The Community Innovator Award is provided by Innovation Credit Union. It is designed to recognize the innovative and implementable community engagement ideas of Innovation Credit Union members.

A total of two (2) awards of \$2,000 each will be provided annually for students actively enrolled in or accepted to any full-time, post-secondary program at Great Plains College. Representatives from Innovation Credit Union and Great Plains College will base their selection of the award candidates based on the eligibility criteria below.

### **Eligibility**

To be eligible, applicants must be currently enrolled in a Great Plains College full-time, post-secondary program. Students who have been accepted to a Great Plains College full-time, post-secondary program beginning in Fall 2018 are also eligible to apply. The applicants must be current Innovation Credit Union members. Potential applicants who are not Innovation Credit Union members can stop any advice centre/branch location or apply online for a free No-Fee Account to qualify. Applicants must also brainstorm and contribute innovative ideas for Innovation Credit Union to become more actively engaged in the communities in which they serve. These ideas can vary in scope and reach — a focus must be on unique, creative and implementable ideas.

### **Application Form**

The completed application form may be submitted by email, in person or mail. Confirmation of acceptance to or enrolment in the full-time post-secondary program and proof of Innovation Credit Union membership for the application, must be supplied in order to be considered. Completed applications must be received on or before **April 30, 2018**.
