



INNOVATION CREDIT UNION COMMUNITY INNOVATOR AWARD

About the Award

The Community Innovator Award is provided by Innovation Credit Union and matched by the Saskatchewan Innovation and Opportunities Scholarship program. It is designed to recognize the innovative and implementable community engagement ideas of Innovation Credit Union members.

A total of four (4) awards of \$2,000 each will be provided annually for students actively enrolled in or accepted to any fulltime, post-secondary program at Great Plains College. Representatives from Innovation Credit Union and Great Plains College will base their selection of the award candidates based on the eligibility criteria below.

Eligibility

To be eligible, applicants must be currently enrolled in a Great Plains College full-time, post-secondary program or have been accepted to a Great Plains College full-time beginning in Fall 2019. The applicants must be current Innovation Credit Union members. Potential applicants who are not Innovation Credit Union members can stop any advice centre/branch location or apply online for a free No-Fee Account to qualify. Applicants must also present an innovative idea for Innovation Credit Union to become more actively engaged in the communities in which they serve. The idea needs to be unique, creative and able to be implemented.

Student applying for this award are also eligible for the Great Plains College entrance scholarships.

Application Form

Confirmation of acceptance to or enrolment in the full-time post-secondary program and proof of Innovation Credit Union membership for the application, must be supplied in order to be considered. Completed applications must be received on or before **May 31**st, **2019**.

To apply for the award, please submit the following by email, mail or in person on or before May 31st, 2019:

- Completed application form, signed and dated
- Community Innovator Ideas Statement, no longer than 500 words include things such as why you think your idea is worth implementing, how would it be implemented, and costs
- Proof of full-time, post-secondary program enrolment or acceptance at Great Plains College
