# Dr Noble Irwin Regional Healthcare Foundation – Great Plains College CHASE THE ACE: OFFICIAL RULES ("RAFFLE")

**OFFICIAL RULES**: By participating, entrants agree to be bound by these Official Rules and by the decisions of the **DR. NOBLE IRWIN REGIONAL HEALTHCARE FOUNDATION AND GREAT PLAINS COLLEGE**, which shall be binding and final as to all matters related to the RAFFLE. The RAFFLE is subject to all applicable federal, provincial, and local laws.

**NET PROCEEDS**: All net proceeds of the Raffle will benefit **DR. NOBLE IRWIN REGIONAL HEALTHCARE FOUNDATION AND GREAT PLAINS COLLEGE**, (hereafter known as "HEALTHCARE FOUNDATION & GREAT PLAINS") and the programs and charitable donations that HEALTHCARE FOUNDATION & GREAT PLAINS supports.

## CHASE THE ACE GAME:

### PURCHASING RAFFLE ENTRIES

**PRICE**: The following prices and corresponding "ticket numbers" are available for purchase: 1 ticket for \$10.00, 10 tickets for \$25.00, and 50 tickets for \$50.00.

**TICKET AVAILABILITY:** Ticket sales will be made available on the <a href="www.drirwinfoundation.com">www.drirwinfoundation.com</a> & <a href="www.greatplainscollege.ca">www.greatplainscollege.ca</a> website every week starting WED Jan. 13, 2021 with the first draw being Thursday 4:00pm Jan. 21, 2021. Cut-off for ticket purchases will be at 3:45pm every Thursday the raffle is active with the draw being at 4:00pm. Sales will resume approximately 30 minutes after each draw for the following week for a maximum of 51 weeks.

**ELIGIBILITY TO ENTER**: During the dates and times and other details specified below, tickets are available for purchase OVER THE INTERNET by anyone **19 years** or older in Saskatchewan or by phone at 306-778-5825. Tickets purchased by phone will be mailed if requested.

The following persons are prohibited from purchasing tickets in the HEALTHCARE FOUNDATION & GREAT PLAINS Raffle:

- Employees, Directors or Executives of Tap 50:50 Event Consultants Ltd.; and
- Any individual in charge of card/envelope security
- Those acting as a proxy

Employees and their families of the Dr. Noble Irwin Regional Healthcare Foundation and Great Plains College are eligible to purchase tickets.

#### **GENERALITIES OF THE GAME**

**DRAW SELECTION:** A single ticket number will be selected each week by a gaming lab certified Random Number Generator (RNG) from all raffle ticket numbers sold during the week leading up to the draw. The draw will be electronically conducted from the Dr. Noble Irwin Regional Healthcare Foundation office at 2051 Saskatchewan Dr, Swift Current, SK S9H 0X6, at approximately 4:00PM and streamed live on Facebook. HEALTHCARE FOUNDATION & GREAT PLAINS will have a minimum of two

people present at each draw following social distancing practices. Purchasers do not need to be present to win and social distancing practices will be followed.

**WEEKLY WINNER:** Each weekly draw winner will receive a single cash prize equal to 20 percent of all ticket sales collected during the week. The winner will be contacted by phone and asked to choose an envelope from the remaining envelopes that contain cards. The chosen envelope will be opened and revealed. If after 3 attempts over 15 minutes, the winner hasn't been contacted, A DESIGNATED PROXY WILL CHOOSE AN ENVELOPE FOR THE WEEKLY WINNER. THE DESIGNATED PROXY WILL BE ONE OF: Gladys Martens or Eric Taseera Lwanga.

**PROGRESSIVE JACKPOT WINNER:** If the envelope associated with the winning weekly draw ticket reveals the Ace of Spades (including week 1), the weekly draw winner will also receive the Chase the Ace Progressive Jackpot, consisting of 30 percent of all ticket sales collected over all weeks. The Raffle is then concluded. It will be up to HEALTH FOUNDATION & GREAT PLAINS if they wish to restart the raffle again and whether the raffle will be re-seeded subject to SLGA approval.

**SECONDARY PRIZES:** If the envelope associated with the winning weekly draw ticket reveals any playing card other than the Ace of Spades, the game continues. All tickets from the previous week are then voided and ticket sales commence for the next weekly draw.

In addition to the 20% prize the weekly winner may receive a Great Plains Swag Gift Basket, if he/she chooses the following cards: six of any suit (four prizes would be available valued at \$100 each)

**GAME PLAY OUT:** If the game is not concluded by the end of the licensing period according to the dates of our SLGA license, the game will be played out on the last Thursday before license expiration which will be January 13, 2022. RNG draws will be made and envelopes selected until there is a winner. There will be no sales between these draws and if the 20% prize weekly winner does not choose the ace, only the 30% progressive jackpot will be eligible to be won by subsequent draws.

**NUMBER OF TICKETS:** There will be 30,000 \$10 tickets available, 125,000 sets of 10 tickets for \$25 and 30,000 sets of 50 for \$50.00 tickets totalling \$4,925,000 tickets for sale for a total prize value of \$2,462,500 plus \$400 for secondary prize packages and the jackpot will be seeded at \$2000 for the first draw for a **grand total of \$2,464,900**. The original Progressive Jackpot will be seeded at \$2,000 and subsequent games may or may not be seeded at HEALTHCARE FOUNDATION & GREAT PLAINS discretion. The total number of tickets offered for sale is 2,780,000.

**POSTING WINNERS:** The winning ticket number will be posted to <a href="www.drirwinfoundation.com">www.drirwinfoundation.com</a> & <a href="www.greatplainscollege.ca">www.greatplainscollege.ca</a> following each weekly draw, along with the weekly prize amount and the revealed playing card associated with the weekly winning ticket. Winning information will be streamed live on Facebook.

**CARD/ENVELOPE SECURITY:** 52 cards from a custom made Chase the Ace deck of cards will originally be counted, and the Ace of Spades confirmed to be in the deck. The cards will be shuffled and, face down, be placed into non-transparent envelopes and sealed. The appointed coordinator from the organization, will then shuffle the envelopes and another person designated by the HEALTHCARE FOUNDATION & GREAT PLAINS will number the sealed envelopes from 1 to 52.

**ATTENDANCE AT DRAW:** Ticket holders do not have to be present at the draws in order to win or to claim their prize. The winner will also be contacted by phone. Social distancing is encouraged.

**UNCLAIMED PRIZES:** Will be secured for a period of 1 year following each weekly draw. Unclaimed prizes after this time period will be reported to, and a charitable allocation will be approved by, the SLGA.

**CLAIMANTS:** The winner must provide their full name, address and phone number and identification upon claiming their prize.

#### LEGAL
